Preface

This volume contains proceedings of the International Scientific Conference «Social and Cultural Transformations in the Context of Modern Globalism, which was held on 20 - 21 October 2023, in Kh. Ibragimov Complex Institute of the Russian Academy of Sciences, Grozny, Russia.

The objective of conference is to establish an academic discussion on cultural and social problems relevant to ethnic, professional, and social communities in Russia and surrounding states. The event is supposed to be dedicated to the discussions, opinions, and reports concerning cultural, legal, historical, and political aspects of social transformations altering local communities and affecting global trends.

The International Conference "Social and Cultural Transformations in the Context of Modern Globalism" (SCTCMG 2023) is an interdisciplinary discussion platform, which brings together both teachers and researchers. This conference is attended by specialists in social policy, history and environmental protection, public figures, and representatives of state authorities. The geography of the participants covers various regions of Russia and the EAEU countries, as well as Asia and Western Europe.

Four keynote speeches were made by the local distinguished scientists. Two plenary sessions were organized: North-Caucasus in the Global World, Novel Trends in Intercultural Intergration. Each session was comprised of five reports. Several workshops were organized. In the course of the meetings, participants had an opportunity to learn more about the North Caucasus, its culture, people and history. Thematics sessions were organized as follows: 1) Science, religion and art in cultural discourse, 2) Cultural and historical legacy preservation, 3) Problems and prospects of philology and journalism, 4) Focal problems of linguistics and literary studies, 5) Interrelation between humanities, engineering, social and natural sciences, 6) Relevant issues of legal philosophy, 7) Lifelong learning: psychological, pedagogical, philosophical aspects, 8) Ecosystems of engineering entrepreneurship, 9) Science as a social enterprise, 10) Ethics and moral responsibility of an engineer

No specific conference management system were used. All the correspondence were handled via email. 175 abstracts and registration proposals received. 83 papers were accepted and presented. Each presenter was given 10 minutes on presentation, up to 5 minutes on discussion, 3 minutes on debates. Peer review process was managed without use of any specialized software. Web service Antiplagiat.ru was used to detect plagiarism. All papers were subjected through single-blind peer review process by two reviewers. The number of submissions received was 175 and reviewed was 110. 50 manuscripts were accepted as is, 33 manuscripts were accepted after revision indicating an acceptance rate of 62%. Total 25 peers involved in the review process. 14 out of 25 reviewers were invited from the outside of the committee. Reviewers had to answer the following questions: 1) Does the contribution fit the scope? 2) Does the contribution feature original research? 3) Are the results and conclusions adequate? 4) Does the presentation style meet academic standards?

The conference organizing committee thanks all the participants and organizers of this conference for their fruitful work. Thanks to our efforts, this conference was held once again. We hope to continue this cooperation next year and invite you to take part in the next conference.
